

## Russian3DScanner Wrap End User License Agreement

Please read this Agreement carefully. By downloading and/or using all or any portion of the software you accept all the terms and conditions of this Agreement. If you do not agree, do not use the Software.

### 1. LICENSE

Russian3DScanner grants to you a nonexclusive License to use the Software only in accordance with the terms and conditions set forth herein.

The terms used in this Agreement, have the meaning ascribed to them in this Section 5 or elsewhere in this Agreement.

### 2. RIGHTS AND RESTRICTIONS

You agree not to transfer, assign, rent, lease, sublicense, or lend the Software to any other person or entity, except as expressly provided herein. You may not distribute or otherwise make the Software available to any third party.

The source code of the Software shall not be made available to you.

### 3. USE OF SOFTWARE

#### 3.1. TRIAL LICENSE

Commercial use of the Software is forbidden under a Trial License.

#### 3.2. INDIE LICENSE

If you are accepting the terms of this Agreement on behalf of an Organization under Indie License, you warrant to Russian3DScanner that your revenue or annual budget does not exceed USD 100,000.

If you are a User or an Organization under a Indie License, you may commence a project using only Indie License and subsequently upgrade all (but not less than all) of your Indie License to a Pro License by contacting Russian3DScanner.

As a User you may install the License on two different computers, provided that these computers belong to you and that you shall not be allowed to use both copies simultaneously.

#### 3.3. PRO LICENSE

If you are an Organization with revenue or annual budget exceeding USD 100,000, Russian3DScanner is unwilling to license the Software under the Indie License to you and you must purchase a Pro License.

### 4. WARRANTY AND LIMITATION OF LIABILITY

You expressly acknowledge and agree that use of the Software is at your sole risk. The software and related documentation are provided "AS IS", without warranty of any kind.

Russian3DScanner does not, either expressed, implied or statutory, make any warranties, claims or representations with respect to the Software, including, without limitation, warranties of quality, performance, noninfringement, merchantability or fitness for use or a particular purpose, unless explicitly stated otherwise in this agreement.

Russian3DScanner further does not represent or warrant that the Software will always function uninterrupted or errorfree.

No oral or written information or advice given by Russian3DScanner or by any of its representatives, agents shall create a warranty.

Russian3DScanner shall not be liable for any damages (including direct, indirect, incidental, consequential and special damages) whether suffered by you, even if Russian3DScanner was advised of the possibility of such damages.

## 5. DEFINITIONS

"Russian3DScanner" is a limited liability company registered at 114/12-8 Lomonosova str., Voronezh, Russian Federation, which is a developer of the Software.

"License" shall mean the limited right to use the Software as detailed in this Agreement.

"Organization" means any company, limited liability company, corporation, partnership, joint venture or other form of business organization.

"Software" means the Russian3DScanner proprietary software product Wrap, licensed to you under this Agreement. The term "Software" shall also include any documentation, upgrades, modified versions, updates, additions, and copies of the Software licensed to you by Russian3DScanner, if any.

"Trial License" means a License granted to a User or an Organization for a limited duration (30 days), to enable the User or the Organization to evaluate the Software and to determine whether to purchase the non-trial version of the Software.

"Indie License" means a License to use the Software granted to either a an individual, being or not a professional user, or a commercial legal entity, with revenue not exceeding USD 100,000 during the prior fiscal year.

"Pro License" means a License to the Software granted to an Organization which annual revenue exceeds USD 100,000.

"User" means an individual person who is authorized by Russian3DScanner to use the Software.

## 6. COPYRIGHT

The Software is owned by Russian3DScanner, LLC., and its structure, organization, and code are valuable trade secrets of Russian3DScanner. You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble, or otherwise attempt to discover the source code or modify the functionality of the Software.
